SURAPOL OPASATIEN

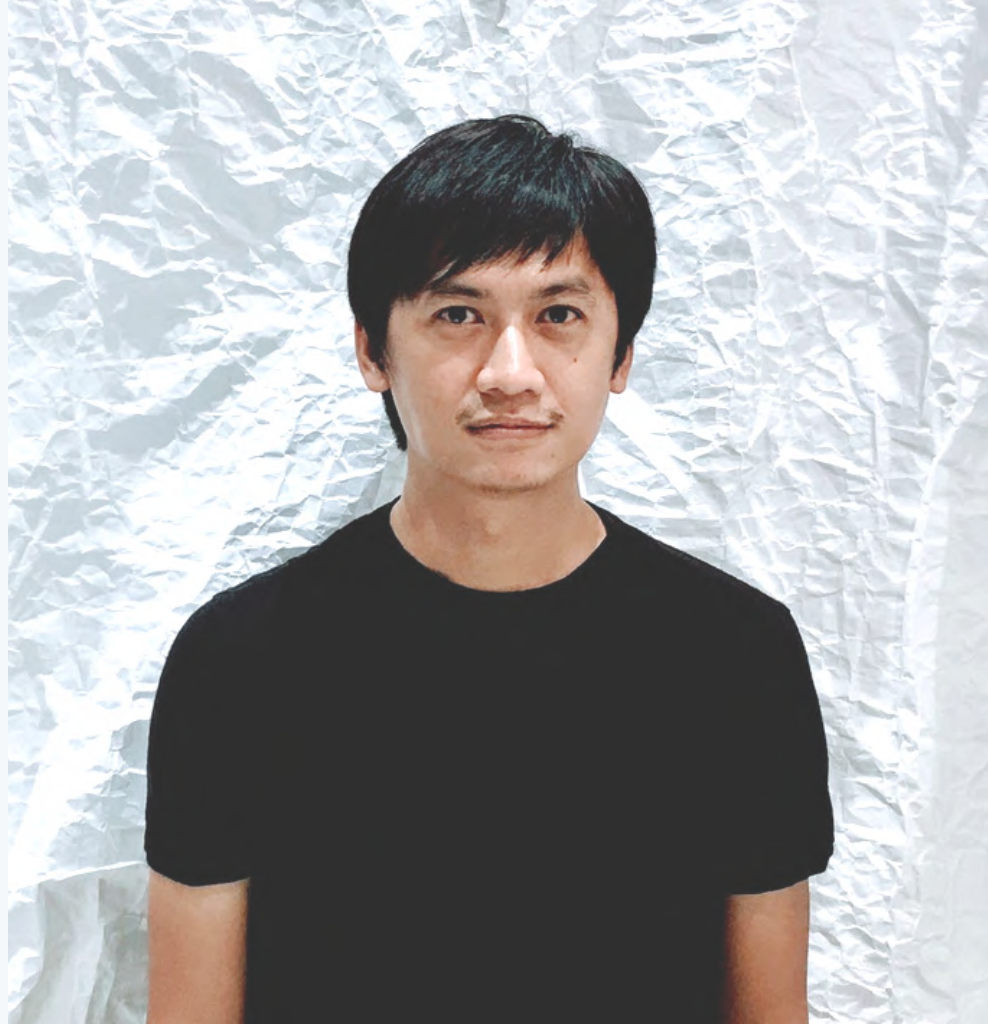
